Zero Tolerance Policy

There are members of the Mason-Dixon Credo community who are in recovery from addiction to alcohol and/or illegal substances. In order to protect the integrity of the Mason-Dixon Credo ministry, as well as to protect our members who are in recovery, Mason-Dixon Credo has a Zero Tolerance Policy regarding the possession and / or use of alcohol and/or illegal substances at any and all Mason-Dixon Credo events. This includes persons who have an official presence at an event, as well as persons who have accompanied someone to the event.

- 1. Mason-Dixon Credo events include, but are not limited to, the following:
 - a. Team meetings, including cadre meetings
 - b. Gatherings
 - c. The Weekend
 - i. Participation as a Team member
 - ii. Participation as a Candidate
 - iii. Participation on the Agape Team
 - iv. Participation in Candlelight
 - v. Attending the Closing service
 - d. Board meetings
 - e. 4th Day Workshop
- 2. "Official presence" means a person who is a Team member, Board member, Agape Team member, Candidate or 4th Day Workshop coordinator and/or presenter.
- 3. Actions
 - a. If a person is found to be in possession of alcohol and/or an illegal substance, s/he will be informed immediately of the Mason-Dixon Credo Zero Tolerance Policy.
 - i. The person should retain possession of the substance. Another person should <u>not</u> take possession of it.
 - ii. If the person desires to get rid of the substance, do <u>not</u> allow him/her to flush any drugs as they may contaminate the ground water.
 - b. If a trained observer is reasonably certain that a person is under the influence of alcohol and/or an illegal substance, that person will be informed immediately of the Mason-Dixon Credo Zero Tolerance Policy. Trained observers include the following:
 - i. Law enforcement officer
 - ii. Mental Health professional
 - iii. Certified Substance Abuse Counselor
 - c. If a person is found to be in possession of and/or under the influence of alcohol and/or an illegal substance, the following additional action(s) will be taken, according to the role of

the person in question:

- i. Unofficial presence: the person shall be asked to leave immediately.
- ii. Team member: the person shall be asked to leave immediately. If the "infraction" occurs at a team meeting, the person shall meet with the Cadre within the next seven (7) days to determine if s/he will be allowed to continue to serve on the Team. If the "infraction" occurs on the Weekend, the person shall leave the Weekend immediately.
- iii. Candidate: the person shall be asked to leave immediately. The person will be eligible to be invited to participate on a subsequent Weekend.
- iv. Board member: the person shall be asked to leave immediately. The Board will pray about the situation and determine at the next Board meeting if the individual will be removed from the Board.
- v. 4th Day Workshop coordinator and/or presenter: the person shall be asked to leave immediately.

Serving on a team represents a commitment of time and financial resources. It could be considered to be like going on a mission trip, without the travel. If you find that you are experiencing financial challenges, we encourage you to solicit financial support from your church and/or fellowship. The following sample letter is provided as a starting point:

Sample letter:

Dear Brothers and Sisters in Christ,

I would like to tell you about a ministry I am involved with called Credo, which means, "I came to believe." The ministry presents a 3-day retreat, blending elements of the Kairos ministry with the Walk to Emmaus format, with the understanding that those who attend may or may not have a walk with the Lord. Many of the people who attend are in recovery from addictions or other dysfunctional behaviors or lifestyles, or have been affected by the hurts, habits or hang-ups of another. As a result, even among those who <u>are</u> believers, many have never experienced the love of Father God. It is an awesome experience on these weekends to see people accept Jesus as Savior, be set free from shame, condemnation and unforgiveness, and open up before your eyes in response to the love of God poured out upon them.

I believe it is God's plan for me to serve on the team providing the 3-day retreat. However, each team member is responsible for his/her own expenses toward the weekend. Currently, I do not have the funds to pay the full team fee of \$150. Since this is a mission where lives are changed, would you prayerfully consider supporting me in this? Any amount would be helpful.

The Weekend retreat is scheduled for $\{ex. April 14 - 17\}$. If you could let me know by $\{ex. March 1\}$ if you could assist me, I would appreciate it so very much.

If you have any questions regarding Credo, I would be very happy to provide you with as much information as I can.
